# To the Consumer:

- 2. This coupon will only be valid if you purchased a Samsung washing machine of 11KG or over 11KG.

# 3. To claim your digital coupon

- a. Complete the form at http://www.persil.com/uk/persilxsamsung-coupon.html; For the entry to be valid, you must have proof of purchase, i.e. Serial number of the washing machine. For the cashback option, you must also keep a copy of the original till receipt.
- b. You will receive a link to the digital coupon via text and email once you have completed the form.
- c. You have two options to redeem your digital coupon:
  - i. For a discount when purchasing a qualifying Persil product in a participating store; OR
  - ii. To claim cashback against a qualifying Persil product purchased in a participating store.

# 6. To use your digital coupon for a discount in participating stores:
